1. Obtaining a body code

Every potential beneficiary (lead beneficiary/beneficiary) needs to have a "body code" in the MIS. It could be the case that the beneficiary is already in the system and has already a body code from the previous programming period. The potential beneficiary is advised to check both the system and the list of bodies/beneficiaries provided in the website of the Programme, in order to find its body code. In case the potential beneficiary needs to acquire a new body code, the following instructions must be followed to obtain one:

1. The potential beneficiary needs to fill in its required details in the excel file: Body_Code_Request_2014-2020.xls. A print screen of this excel file is shown in Picture 1;
2. The completed excel file is send via e-mail to the following email address: jts_grbg@mou.gr;
3. The same form should be completed, in case the beneficiary would like to update / change / complete data concerning body details.

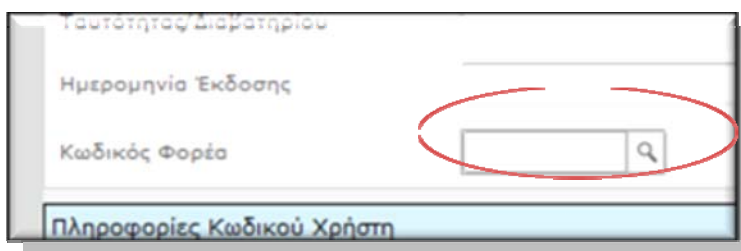

1.1 Useful notes for body codes

A Potential Beneficiary (lead beneficiary/ beneficiary /), can at any time check via the MIS whether they have obtained the relevant "body code" or not (verifying that the body code acquisition process is successfully completed) by following the steps described below:

1. Follow the link: http://esub.mnec.gr/ops_sec5/register.zul
(This URL is accessible to everyone and no credentials are needed)
2. Locate the field with the magnifying glass and click on it as shown in the Picture below (Picture 2):

3. Type some keywords (in English or in Greek) of the relevant body's (entity's / organization's) title in the search box and click on the magnifying glass (Picture 3):

Once the body code is found, select it and then double click on it. Another way for a potential beneficiary (lead beneficiary/ beneficiary /) to check whether it is registered in the MIS or have acquired a body code is to visit the following url: <http://www.ops.gr/Ergorama/index.jsp?menuitem=kodikessa1420&tabid=0> and click the file: "*Φορείς (10/10/2016).xls*". This excel file lists all registered bodies in the MIS. This list is updated periodically.



Applicants should submit their request for body code at least fifteen (15) calendar days before the call's deadline.



Data modification (i.e address, name of legal representative etc.) is an ongoing procedure and it will be continued later for approved projects via the designated project officer of the Joint Secretariat.

2. Obtaining a User Account/login

The lead beneficiary is the one that will enter the data of the proposed proposal to any given open call. In order to access the OPS 2014-2020 (MIS), the Lead Beneficiary must apply for a User Account Access Code with the appropriate rights, in order to submit the proposal.

The system has four levels of user access rights:

- Read Only: the user can only read what other users have entered in the system;
- Entry: the user can read and enter data in the system. The user can by default read all proposals entered in the MIS by all users that belong to the same body code as him;
- Submission of Progress Reports: the user can read, enter data in the system and submit the progress reports if and when the proposal is approved by the MA;
- Submission of a new Proposal: the user can read, enter data in the system, can submit the progress reports, if and when the proposal is approved by the MA, and submit the new project proposal to the MA.

It is strongly recommended for Lead Beneficiaries to request¹ at least two separate accounts with different level of access rights:

- one with access right of: "Submission of a new proposal- Υποβολή αίτησης χρηματοδότησης ΤΔΠ" and
- one with access right of: "*Submission of progress reports/Υποβολή δελτίων*" or "*Entry/Καταχώρηση*", in order to guarantee the level of correctness and security of the submitted proposals.

In order to achieve the above user structure, at least two users of the same body code apply for two separate account access. The two levels of the users can be described as:

- *High level SUBMISSION*: The user/users of this level have access to all proposals of the body , they supervise and take the final decision and can submit them;
- *Low level ENTRY*: These users can create and work their own proposals without submission rights.

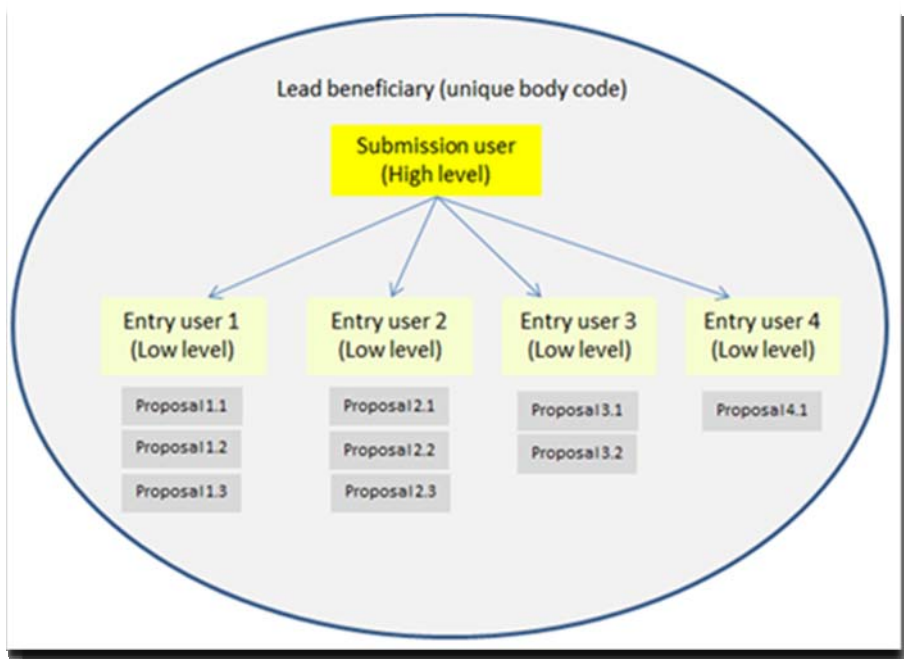
For universities or big scale entities, it is recommended to request multiple Read – Entry rights (*Low level ENTRY*) users for different internal departments, in order to work on separate proposals and only a few users with "Submission of a new Proposal" (*High level SUBMISSION*) rights user/s.

Please have in mind that all users that belong to the same body (have the same body code) are able to see all proposals that have been submitted by their body (even if, in the case of Universities, belong to different departments).

In order for the users to have access only to the proposals of their own department, they have to state in the User Account Access Form the following:

- The user must have access only to the proposals that are created by him / her. In that case, the user can only see the proposals that have been created by him / her. Only the high Level user of the body will be able to see all proposals created by all users belonging to his body.

2.1 Greek language Users

Electronically submitting a proposal is done through the page <http://logon.mnec.gr>

On the displayed screen (Picture 6), the user selects the key: "Εγγραφή Χρήστη Δικαιούχου ΕΣΠΑ 2014-2020", in order to acquire a User Account code.

The user is then redirected to the screen (Picture 7). The Managing Authority that the user needs to apply for is "ΕΥΔ ΤΩΝ ΕΠΙΧΕΙΡΗΣΙΑΚΩΝ ΠΡΟΓΡΑΜΜΑΤΩΝ ΤΟΥ ΣΤΟΧΟΥ ΕΥΡΩΠΑΪΚΗ ΕΔΑΦΙΚΗ ΣΥΝΕΡΓΑΣΙΑ" MANAGING AUTHORITY OF THE OPERATIONAL PROGRAMMES OF THE OBJECTIVE 'EUROPEAN TERRITORIAL COOPERATION'.

The user needs to complete as least the fields marked with the red asterisk. *If the Body Code/ Κωδικός Φορέα is not filled in, a user account can be created but not activated.* A print out of the form shown in Picture 8 should be signed and stamped, scanned and sent to the Managing Authority via email to the following account jts_grbg@mou.gr.

The body code is found via the search box or on the attached list of bodies/beneficiaries. If it is not found in the system, the user must follow the instructions described in Chapter 1. How to obtain a body code, in order to obtain a body/beneficiary code.

2.2 English language - users

To acquire a User Account code, it is necessary to complete the following form (annex 2) (Picture 8).

The user needs to complete as least the fields marked with the red asterisk. If the Body Code/ Κωδικός Φορέα is not filled in a user account can be created but not activated. A print out of the word document should be signed and stamped, scanned and sent to the Managing Authority via email to the following account **jts_grbg@mou.gr** as a pdf file along with the word

document.

Particular attention should be given to the following points:

- If the proposed 5-8 digit username requested by the potential user is already taken or not acceptable by the systems specifications, it may be partly modified by the MA.
- User credentials are strictly personal. They should not be given or shared with anybody.
- The application for user account form needs to be:

on the left hand side - stamped with the official body stamp, signed by the legal representative of the body (signature and name);

on the right hand side - signed by the applicant below the printed name.

Applicants should submit their application for user account form at least fifteen (15) calendar days before the call's deadline, so that there is enough time to complete all required procedures in time.



The required files (word and scanned pdf) shall be sent by e-mail to: jts_grbg@mou.gr. In case of non-response to a submitted form within 10 calendar days, it is recommended to send a reminder.

3. Electronic submission

3.1 Use of the MIS NSRF 2014-2020



During the electronic submission it is recommended not to use Explorer as a browser. English version of *CHROME, Firefox and Opera* are highly recommended.

Access to the system is done via the page <http://logon.mnec.gr>.



If there is any problem entering the system, security filters constraints and proxy problems should be checked. PopUp blocks should be deactivated.

The user selects the English Version of the system by pressing on the English flag (Picture 9).

The user enters his credentials in the corresponding fields (*username* and *password*) and presses the “Login” button. (Picture 10). If the user has not been granted with system credentials, he must follow the relevant instructions on how to get a Login in Chapter [2. How to obtain a user account](#).

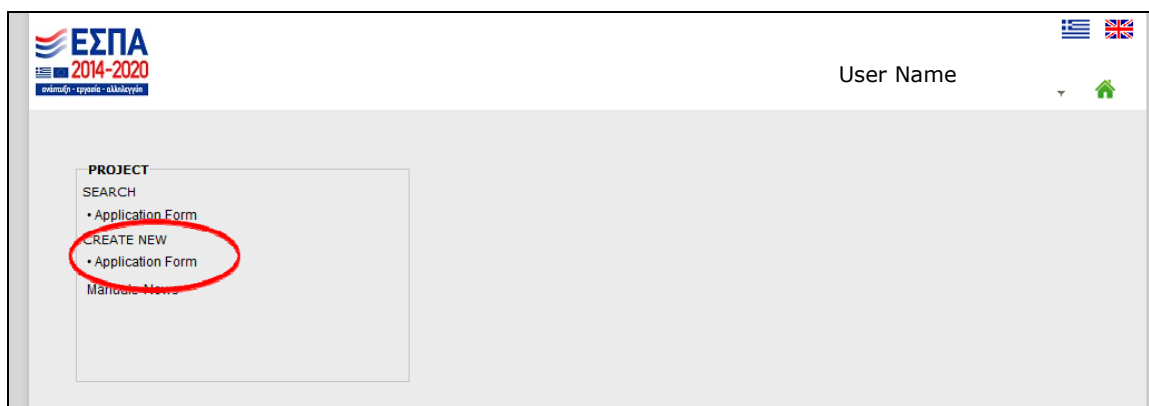

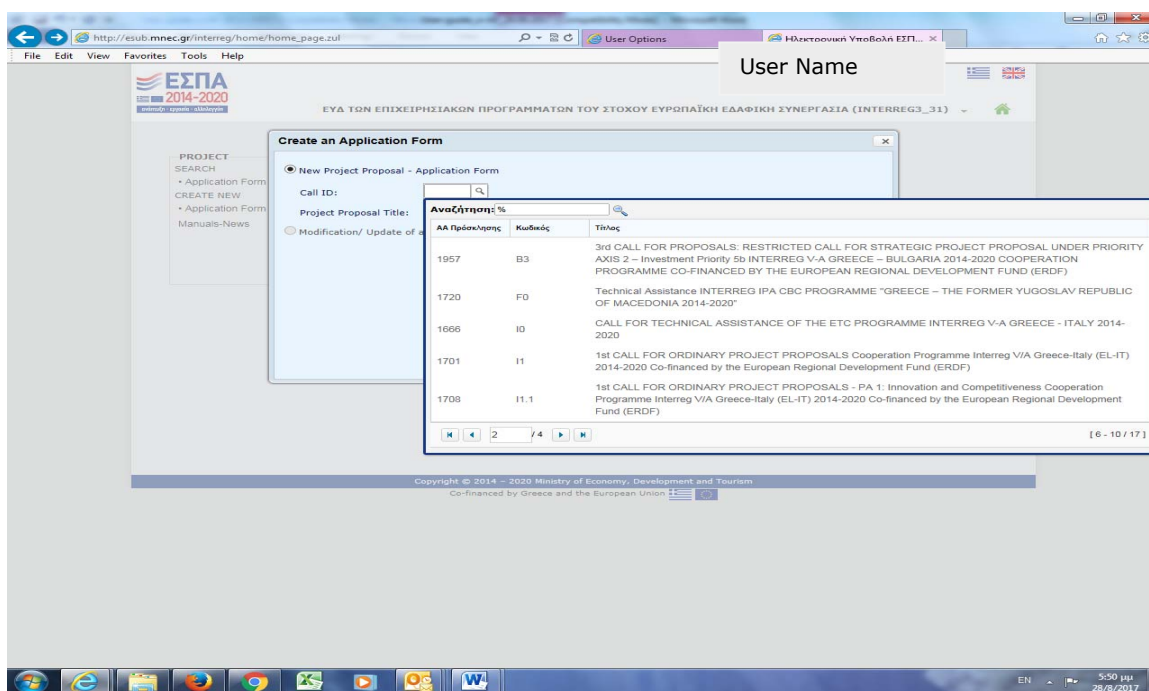
3.2 Electronically Creating a Project Proposal

To create a new Project Proposal, the user shall select the option Create New → Application Form (Picture 12).

The user must select the Call in which he wishes to apply for through the search box "Call ID" (Picture 13). In that list only **Open Calls** are listed.

Several calls of several Programmes could be up and running and will be displayed as the search list. Please be careful while selecting the one in which you would like to apply for.

For submitting a new proposal, the user needs to select the first radio button "New Project Proposal – Application Form" and to fill in the field "Project Proposal Title" and press the OK button. (Picture 14).

By pressing the OK button, the system will dedicate to the project proposal an MIS Code. The title can be edited also in later stages up until the Proposal is submitted to the MA.



3.3 The Project Proposal screens

There are five different Sections that need to be filled in while electronically submitting a project proposal (Picture 15 - 16).

- A. Project Identification
- B. Detail Description
- C. Partnership
- D. Budget
- E. Indicators



While being redirect to the following screen, it is advised to save once again, in order for the system to secure the MIS Code of the Project Proposal.

It is advised to save often while entering data to the system, in order to avoid losing any data.

3.4 A. Project identification

Section A. 'Project identification'

Acronym: An acronym for the Project Proposal is obligatory

Start Date – End date: the user can enter any reasonable *start date* and *end date* provided that the total period will not exceeds 36 months

Section A. "Programme Code"

The *ATP* and the priority axis need to be added by pressing the green add "+" sign. As each project proposal belongs to only one priority, axis the percentage must be 100% (Picture 18).

Wherever there is a Percentage Column, the user must fill it in in such a way that the sum of this column adds up to 100%.

Section A. "Classification"

The user must delete the *Intervention Fields* that are not related to the project by marking the field, choosing 'delete' and then 'save'. It is possible to delete multiple rows at once and then save (Picture 19).

The user preserves the *Intervention Field* that is more appropriate to the project proposal and fills 100% in the Percentage cell.

In the same way, using the keys *add* and *delete*, the user selects the '*Investment priority*' and '*specific objective*' and adds 100% in the Percentage cell for his selections.

It is also obligatory to complete the territory type by adding 100% in the Percentage cell.

It is strongly advised for users to take into consideration the [intervention logic](#) of the Programme.

'Section A. "Brief Project Summary": A brief Description of the project Proposal is obligatory. The maximum number of characters in this field is 3000. (Using the *Chrome* browser, the size of the field may be modified, in order for the full text to appear.)

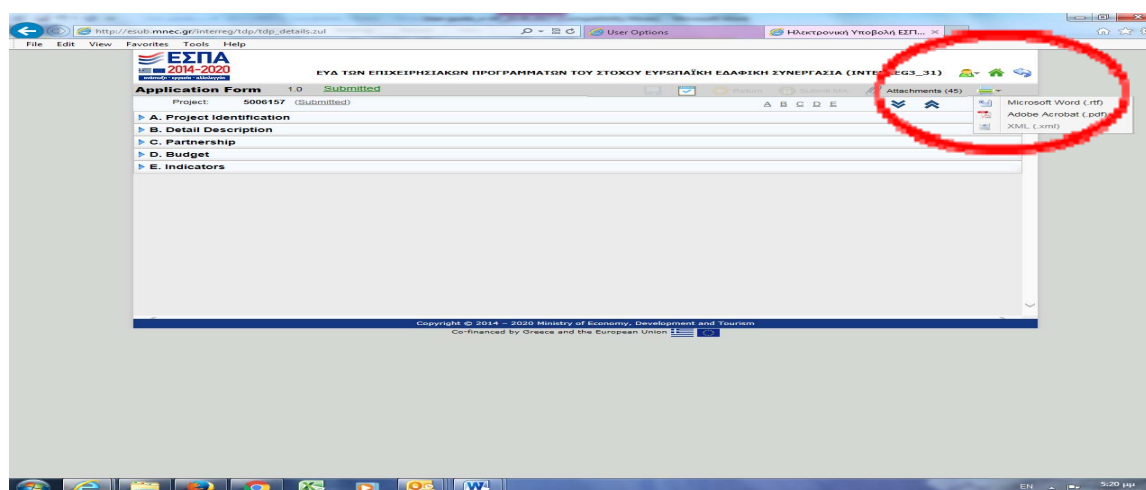
