

What is the Programme all about?

The Programme's total budget is **130.262.836,00** €. It includes co-finance rate of 85% by the European Regional Development Fund (ERDF) and also 15% of national contributions.



The eligible area is consisted by two Greek and two Bulgarian regional administrations, situated at the south-east border of the European Union with a total surface of approximately 40 thousand km² and a population of around 2.7 million people. The area is primarily rural, mountainous and sparsely populated. Demographically the city of Thessaloniki is predominant, concentrating approximately 40% of the area's population.

There are also ten urban agglomerations of more than 50.000 inhabitants and twenty five smaller concentrations with a population ranging from 10.000 to 50.000 inhabitants.

The goal of the Programme is address issues of common interest on an efficient bilateral basis. To this extent, it focuses on four thematic areas of particular value for the cross-border area.



2021 in a Nutshell

2021 was a challenging year for the Program's implementation as it had to adapt to the new reality of the pandemic crisis. In spite of the unforeseen circumstances, the following key milestones took place during the year:

Competitiveness of SMEs: 35 new projects were contracted, involving 123 new beneficiaries. In total, the thematic area numbers **185 beneficiaries**, among which there are **70 private SMEs** receiving direct assistance. All of the projects of the thematic area are on-going.

Environment, Cultural & Natural Heritage: 9 projects finalized within 2021. Given that five projects were finalized earlier in the period, there are still **27 on-going projects.**

Sustainable Transport: The **Strategic Project CROSSBO** remained under full implementation throughout 2021. The scope of the project is to establish an **additional cross-border check point** (axis Dimario – Rudozem) that will improve the local accessibility and mobility.

Social Inclusion: 5 projects finalized within 2021. Given that nine projects were finalized earlier in the period, there are still **10 on-going projects.**

What about spending?

Seven (7) Payment Claims took place within 2021 and the total certified expenditures reached 22.565.729,04 €. The cumulative total expenditures declared by beneficiaries to the Managing Authority until 31/12/2021 was 73.661.351,70 € covering 56,55% of the Programme's total budget.
